POLICY STATEMENT:

Algoma Family Services (AFS) Board members will serve as ambassadors and advocates of Algoma Family Services.

PROCEDURES

Board orientation will also include ...

- 2. Communications protocol ... how we (AFS Executive office) communicates with Board
 - Board members receive copies of Current Board Membership (detailed list) such lists will be updated regularly and forwarded to all Board members
 - Schedule of Board meetings (Calendar of meetings for the current year)
- 3. Review AFS Board manual including:
 - AFS By-laws and Letters of incorporation
 - Transfer-Payment Agency (TPA) Governance and Accountability
 - AFS Board Policies
 - AFS Corporate (Strategic) Plan (Ref. CODE-0015 Vision Mission Values Service Principles
- 4. All new board members will be paired with an experienced board member who will act as a mentor and be available to answer any questions.
- 5. Training with AFS issued technology on how to access SharePoint and AFS email.
