7.1 Policy Review for Accreditation - Update

The Chair stated that the working group has made the necessary changes to the policies, with the exception of one policy that requires further adjustments upon Brenda's return from her vacation. The policy concerning CEO succession underwent the most significant revisions. Once the review of the policies is completed, they will be made accessible to all board members. The expectation is that the revised and updated policies will be presented to the Board for approval at the May board meeting.

Jacob noted that the insurance policy is undergoing renewal and will be presented for approval at the board meeting in May.

7.2 Board Acknowledgement Form

The Chair reminded board members to complete the acknowledgement form in compliance with the accreditation standards.

7.3 The Board Assessment Feedback Survey Result

The Chair mentioned that the survey results are included in the board package and were reviewed during the Governance Committee meeting. The survey indicated that the majority of board members place a high priority on improving the efficiency of board meetings. Areas identified as medium to high priority include maintaining the meeting length to two hours, preparing questions regarding reports in advance, and standardizing board reports.

The Chair noted that he had requested a standardized report template from David Petersson, who provided the DSSAB reporting template. This template will be reviewed by the Leadership Team to determine how it can be customized to fit our needs. Ali suggested that board members review the template and provide their feedback on how they would like the reports to be presented. Uju will be contacting the board members to obtain their feedback. This agenda item will be brought back to the May board meeting for further discussion.

7.4 Board Annual Work Plan/Committee Input

The Chair stated that revisions were made to the work plan, and they include:

- Slate of Directors it was originally scheduled for October but was revised to include a review in May for directors whose terms will be expiring in October or those seeking re-election.
- Officers This was added to the list to ensure that the Governance Committee review the officers for the next fiscal year.
- Audited Financial Statements The review period for the audited financial statements has been
 rescheduled from November to October to align with the Annual General Meeting (AGM).
 Additionally, the meeting in May, which is required for the Finance Committee to review and
 recommend the audited report for board approval, has been rescheduled to June.
- Approval of Annual Budget The approval of the annual budget has been revised from March to September due to the complexities of ministry funding. The Chair stated that, according to accreditation standards, the board is to be provided with a quarterly review of the budget. This will be reviewed at the next board meeting.
- Insurance Review this task was added to the agenda for review in June. However, Jacob noted that the insurance policy renewal takes effect on May 1st. He suggested revisiting the review date so that it precedes the policy renewal date. For now, the review date has been rescheduled to May.

7.6 Youth in Transition Program – Update

Ali mentioned that the contract is currently pending. Additionally, an offer was made to the staff for a part-time position (0.6 FTE) instead of a full-time role due to funding constraints. However, she declined the offer.

7.7 Termination of VAW Contract – Rainy River

Ali noted that we have been providing services to Rainy River for approximately a year, but they have identified a new provider. He pointed out that although this represents a loss in revenue, the agency did not rely on the revenue from that service.



CEO Report

April 23, 2025

Happy New Fiscal Year! With the spring like weather, the anticipation of warmer days fills our spirits for spending more time outdoors and bringing a long winter to an end! With that being said, tragically, a young life was lost due to a senseless act by another youth, and in the mix, another 15-year-old boy is in serious condition. Our thoughts and prayers are with the family of the deceased youth, the youth in the hospital, and the young driver responsible for the accident. A community is in mourning, and our youth will need us now more than ever to help them cope with the impact of this accident. If you, yourself are needing help in coping with this situation, please reach out to me. We are here to help.

The April report is typically one of our shorter reports, given the wind-up of the last fiscal year and start of the new year. The finance report is not completed until May, and from a service perspective our levels are consistent year to year, this year being no different. With the impact from the accident on Sunday, we may see a gradual service demand increase, as children, youth, and families cope with the what has happened. We have made arrangements to ensure those needing help get immediate service, and have extended our assistance to the school boards' mental health counsellors if needed.

Our EDI calendar can be found in the Board TEAMS Folder. I have also attached the newsletter in my email for your easy reference. Two dates to note in May are:

- May 5th Day for Awareness of Missing and Murdered Indigenous Women and Girls. This day brings attention to the high rates of violence faced by Indigenous women, girls, and two-spirit people.
- May 17th International Day Against Homophobia, Transphobia, and Biphobia. This day promotes equality and fights against discrimination faced by the LGBTQ+ community globally.

May is Mental Health Awareness Month, with the first week of May being dedicated to Child and Youth Awareness Week. A calendar of events will be included in this report.

Reconciling our Truth

We are in the process of reimagining our Indigenous Outreach Counsellor position in order to enhance our outreach, build internal capacity to serve Indigenous clients, and further our work in making AFS a culturally safe space for Indigenous peoples, including our education in the 94 calls to action.

Level Setting

Further to the last report on our capacity building training, there are two dates for the Board virtual training, those being:

May 27th and June 25th, 2025

Our staff and leadership team will be participating in similar training sessions.

Connecting the Dots, Closing the Gaps

The Youth in Transition program was transferred to AFS on April 1st, however, we are to formalize this with a signed MCCSS contract. An offer was made to the person currently working as the YIT Worker at Sault College. This person has declined our offer. As the position at AFS will be .6 FTE we are exploring an option of combining this role with another part time position, to make the role full time.

As you may recall, the YIT program is designed to assist CAS youth aging out of care with their transition to independent living. This transition support will include post-secondary enrollment, employment, housing, budgeting, and life skills. The program and position will be located at our Youth Hub.

The Student Nutrition Team is preparing for the delivery of the **Every Breakfast Counts** program this summer. New for this year will be an additional week of support, which is much needed. In past summers, we have provided up to 8800 meals. Information will be shared with the board in June on how you can assist with the delivery of meals to hubs across the city. We thank you in advance for your assistance.

On Thursday, April 17th, Margaret Tuomi, Youth Hub Coordinator, Chera McCutcheon, Counsellor, and I, had the privilege of speaking at the **SOYA Family Matters Conference**. In my remarks I spoke about hope for our community with the Algoma being awarded two HART's Hubs, the funding for the Community Wellness Bus, and the over 5000 visits to the Youth Hub.





Finding a Better Way

I am representing AFS on the **HART's Hub** Steering Committee. Work is progressing, and we are in the process of finalizing an operating budget. The details are embargoed at this time, however, once finalized I will provide the board with a budget overview.

With regard to my work on the **Algoma Leadership Table** as Co-Chair, we have successfully transferred the stewardship of the **Community Safety and Well-Being Plan** to the City of Sault Ste. Marie. For those new to the board, the (CSWBP) is a framework designed to help Ontario municipalities enhance the safety and well-being of their communities. It focuses on proactive, integrated approaches to address local issues and improve overall quality of life. Key components include:

- Social Development: Long-term efforts to improve social determinants of health, such as education, housing, and employment, to reduce the likelihood of harm and victimization.
- 2. **Prevention**: Initiatives aimed at preventing problems before they occur, through community programs and services.
- 3. **Risk Intervention**: Identifying and addressing situations where individuals or groups are at risk, providing timely support and resources.
- 4. **Incident Response**: Effective and coordinated responses to incidents to mitigate harm and support recovery.

Municipalities are required to develop and implement CSWB plans in collaboration with various community partners, including local agencies, organizations, and residents. These plans must be publicly available online.

The goal is to create safer, healthier communities by addressing the root causes of issues and fostering collaboration across sectors.

With regard to the **OHT**, Ontario Health has issued a call for proposals regarding Interprofessional **Primary Care Team (IPCT) Expansion.** This initiative is aimed at enhancing access to primary care services across the province. Deadline for submission is May 2, 2025. Currently there are six organizations interested. Our OHT is hoping to combine proposals and reduce this to three. Here's a brief overview:

Purpose

The expansion seeks to create and expand IPCTs to improve access to comprehensive, coordinated, and patient-centered primary care. This initiative is part of Ontario's broader strategy to ensure every resident has access to primary care by 2029.

Key Components

- 1. **Team-Based Care**: IPCTs consist of family physicians, nurse practitioners, and other health professionals such as nurses, social workers, dietitians, and administrative staff working collaboratively to provide holistic care.
- 2. **Funding and Support**: The Ontario government is investing \$1.8 billion to support the creation and expansion of over 300 IPCTs, with \$213 million allocated for 2025-2026 to establish up to 80 new teams.
- 3. **Targeted Communities**: The first round of proposals focuses on communities with the highest need, identified by postal codes, to connect 300,000 more people to primary care in 2025-2026.
- 4. **Proposal Submission**: Eligible primary care practices and clinicians must collaborate with their local Ontario Health Teams (OHTs) and Primary Care Networks (PCNs) to submit proposals. Each OHT can submit up to five proposals per identified postal code.

Goals

- **Increase Access**: Attach approximately two million people to primary care by 2029.
- **Comprehensive Care**: Enhance the quality and scope of primary care services through interprofessional collaboration.
- **Community Focus**: Address the specific needs of underserved communities and populations.

This expansion is a significant step towards improving the primary care landscape in Ontario, ensuring more residents receive the care they need.

With regard to our **Live-in Treatment Program** we expect a new admission at the end of this month, bringing our total bed count to seven.

With regard to our Youth Hub, the team successfully held the first Federal All Candidates Meeting in succession to the first Provincial All Candidates meeting. We had more youth participate in this meeting, attended by the Liberal, NDP, and Green party candidates. With your voices and that of the community we can impress upon the Government the need for investments in child and youth mental health. Our young people are depending on us!
